DEFINING FAMILY

Dictionary:

- A fundamental social group in society typically consisting of one or two parents and their children.

Normative household development cycle:

- Viewed households as constituted in temporality by a heterosexual couple (or a small nuclear family).

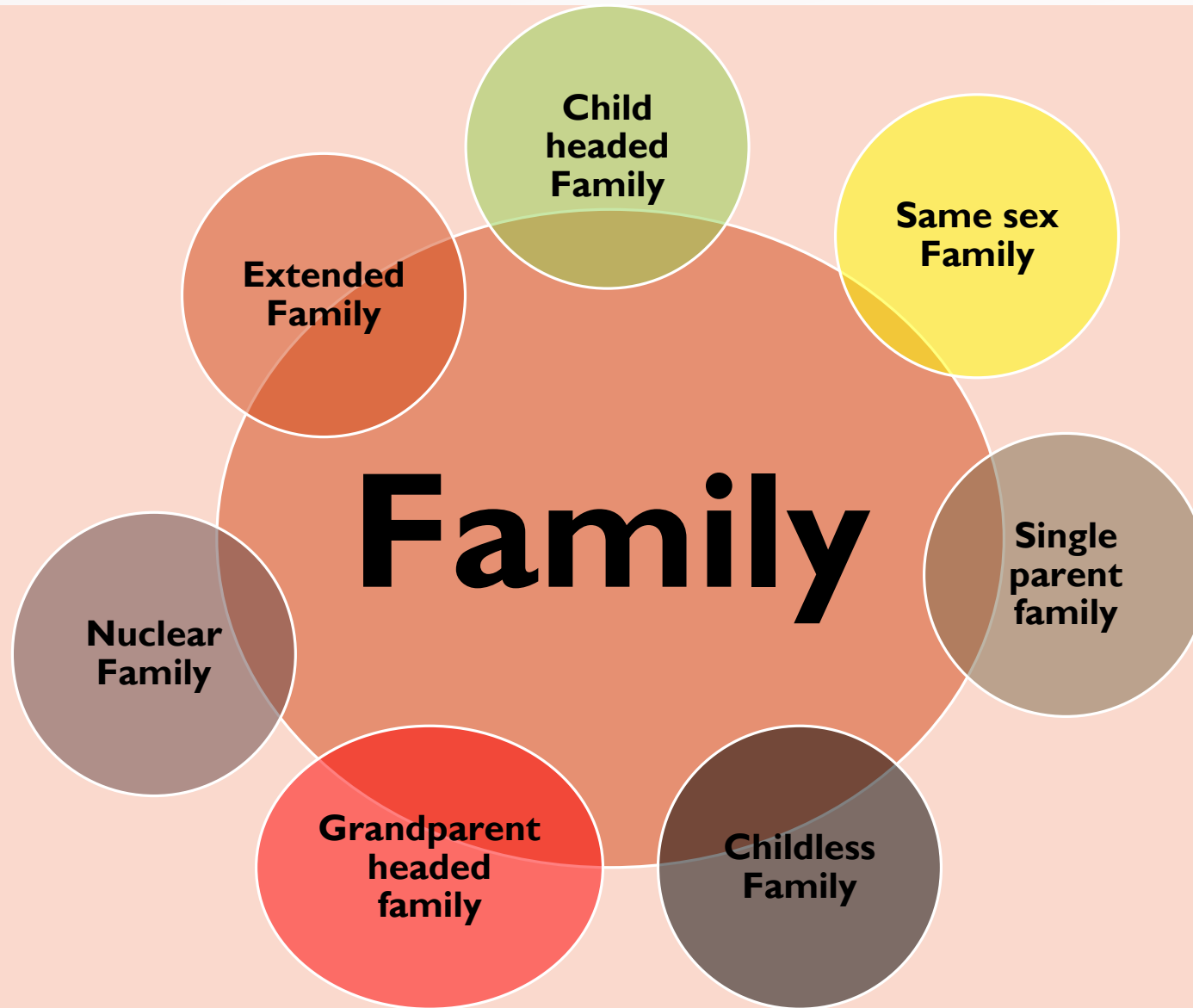


Historical factors that impacted on the SA family

- **Historical and persistent migrant labour:** colonial and later apartheid regimes instituted migratory labour, influx control, and the Immorality Act with immense consequences for the family.
- **Inequality and poverty:** patterns of unequal distribution of resources also played a role in the formation of these households.
- **Education:** the apartheid's legacy in education lives on. In 1953, finances for black and white schools were separated, and black children were given significantly less than white children.
- Families are still recovering from the past wounds.

Post 1994: Factors impacting on family household formation

- High rates of unemployment – job-seekers migrating regularly
- Fertility rate decreasing \longleftrightarrow Socio-economic factors, bio-social factors, proximate determinants
- Spousal separation
- Decline of marriage rates
- Decreasing birth and fertility rates
- Expansive social grants system – giving support to female and grandparent-centred households in particular
- HIV and AIDS – missing generations, child-headed households

Extended Family

- This type of family is constituted by extended relatives in the same household
- It also includes multiple generations in the same household
- Maintained for reasons of cultural preference and survival in the face of poverty

Nuclear Family

- Mother, father and children
- This type of family is slowly changing
- 2010 = **35.5 %**
- 2015 = **34.5 %**

Types of family and households cont.

Grandparent-headed family

- Grandparents have been seen to take over the roles of parenthood to their grandchildren
- This may be due to children being orphaned, parents moving away from homes to find work, or grandparents co-parenting children alongside young parents

2010 = **56.5 %**

2015 = **52.9 %**

Childless family

- “Forgotten family”
- Couple living together
- Choice not to have children/unable to conceive
- 2010 = **2.47 %**
- 2015 = **2.34 %**

Types of family and households cont...



Child-headed family

- Household of members younger than 18 years
- Vulnerable group
- 2002 = **0.7 %**
- 2014 = **0.3 %**



Single parent family

- Most of these households are run by single mothers
- Fathers have been seen taking over the responsibility of caring for their children without the mother being involved
- **Female**
 - 2010 = **38.9%**
 - 2015 = **36.7 %**
- **Male**
 - 2010 = **3.4 %**
 - 2015 = **3.5 %**

Same sex family

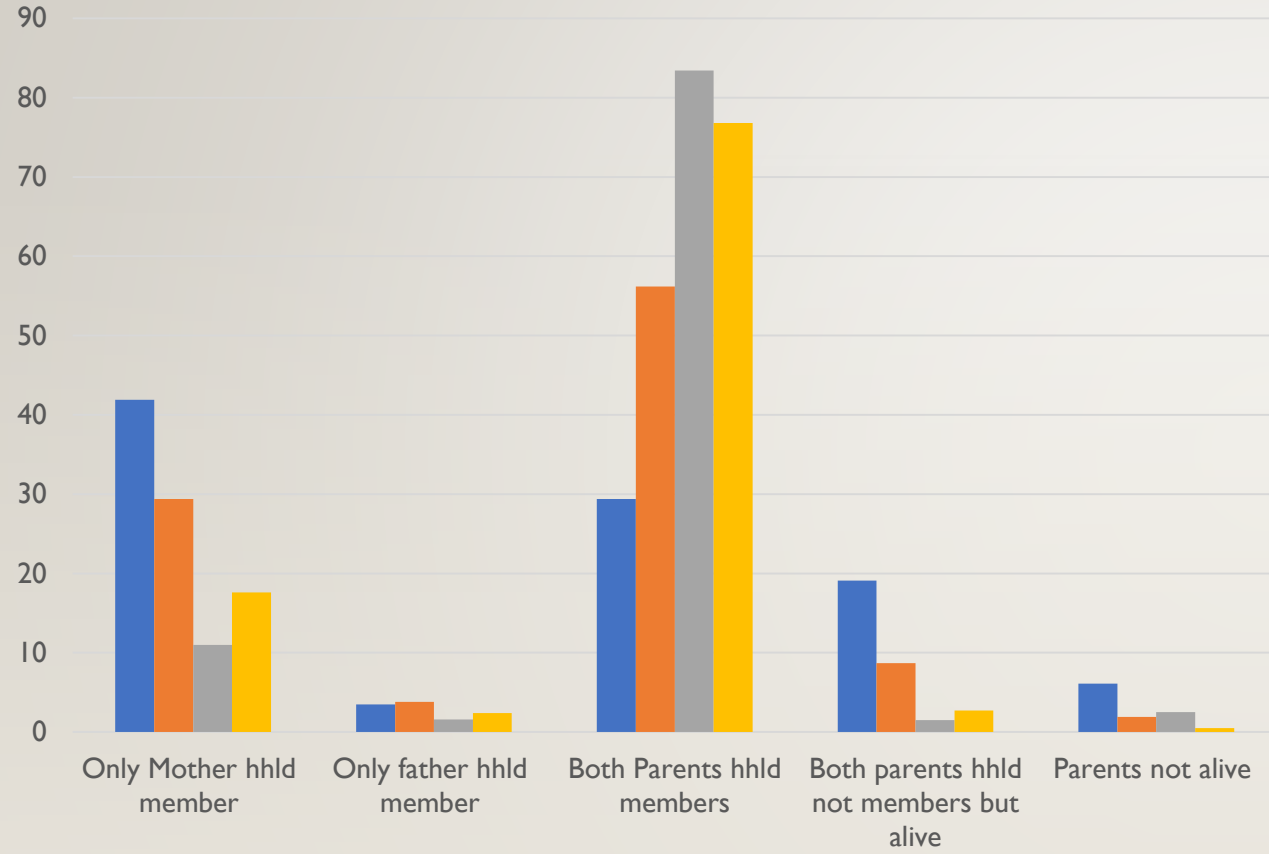
- Were associated with a childless lifestyle
- Slowly growing
- Legalisation of same-sex marriage in 2006
- 2007 = **80**
- 2010 = **867**
- 2015 = **1185**

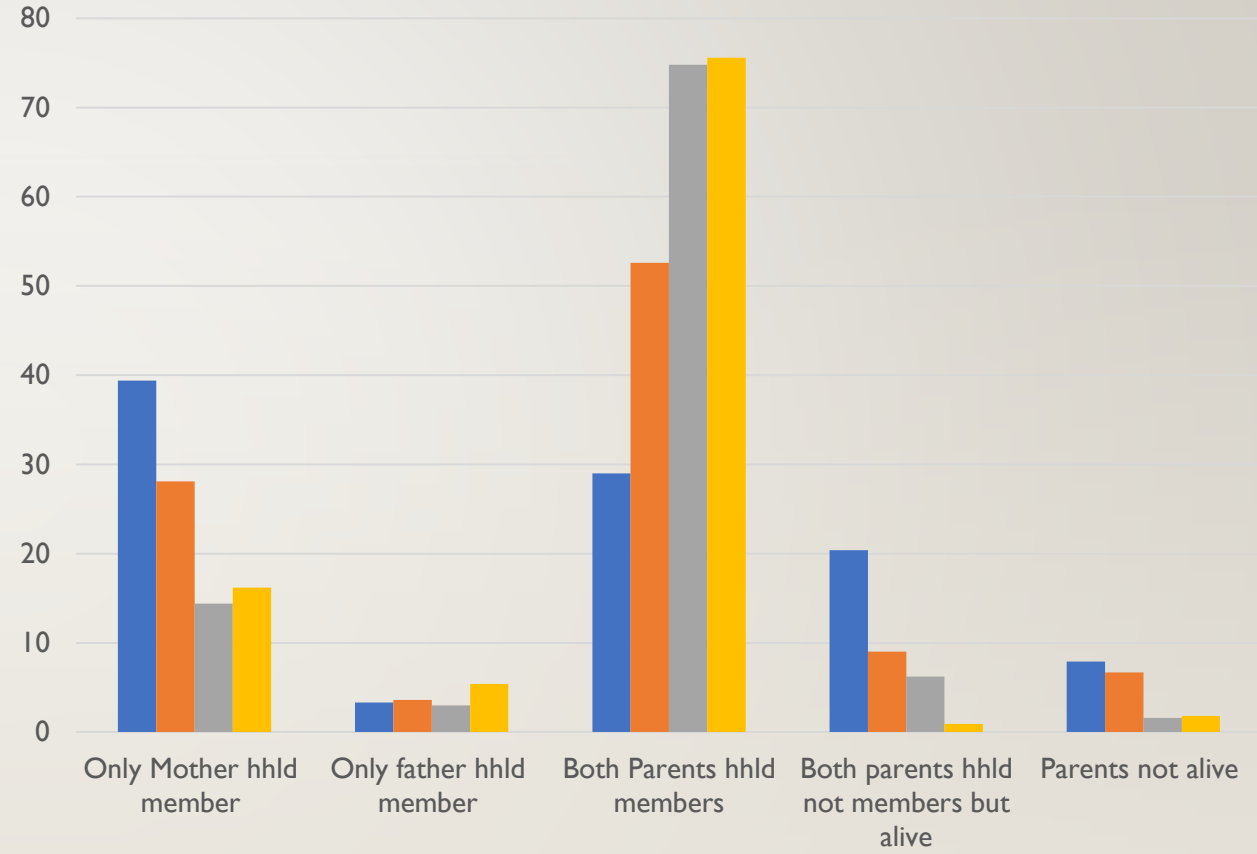

Black African Coloured Indian/ Asian White

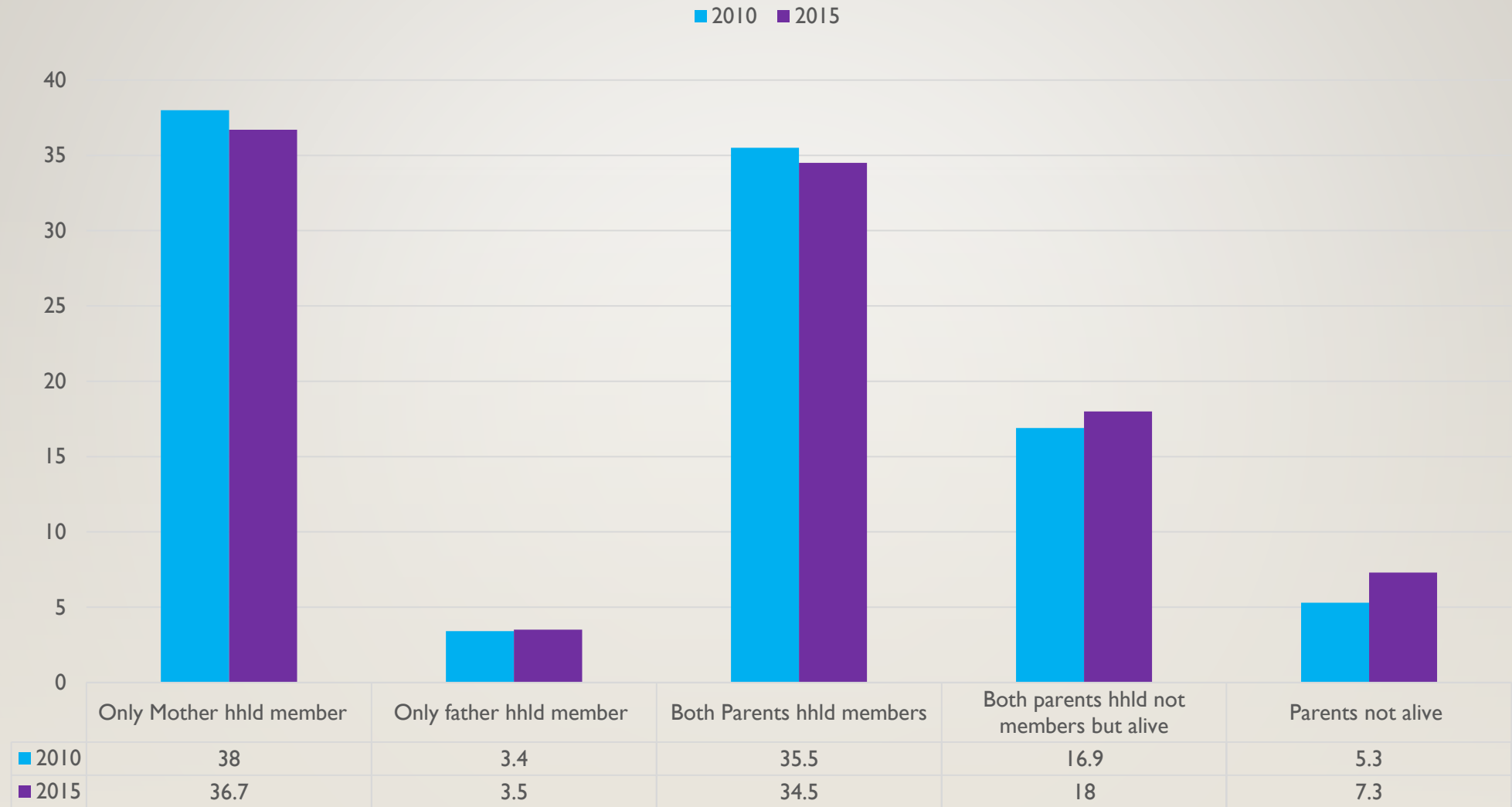

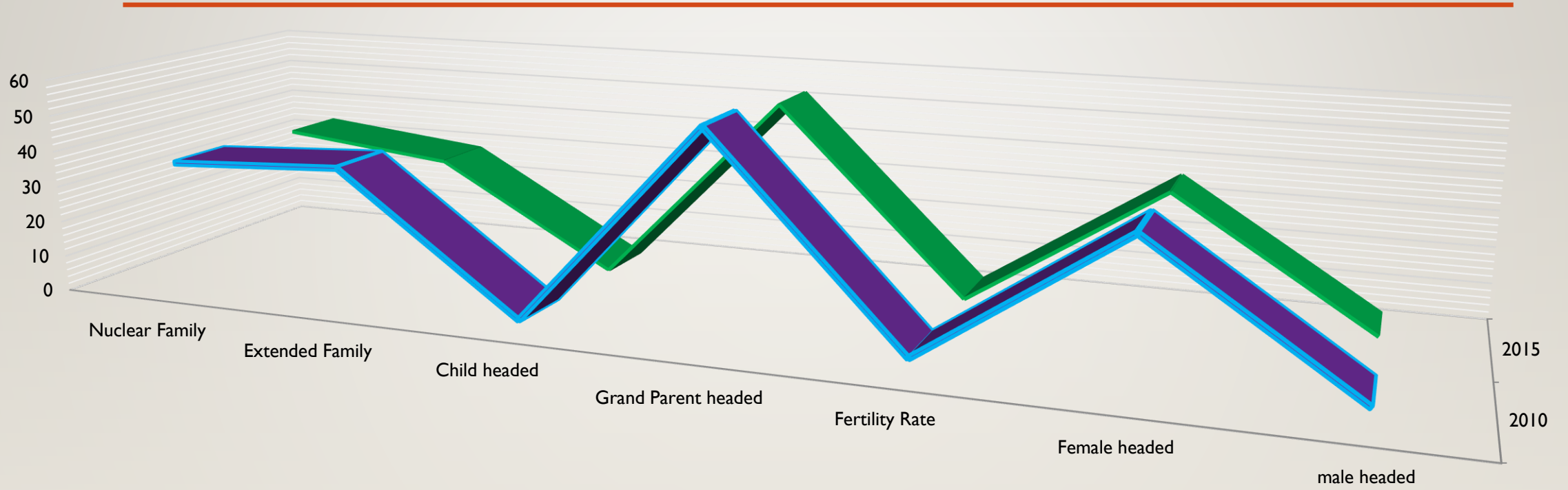
Black African Coloured Indian/ Asian White
